



CJF Member Terms & Conditions

All CJF associates, regardless of rank, are referred to as Members in this document

- 1. Retail sales price:** Our members may charge any price for a CJF certificate or redeem it for CJF products and market or use those.
- 2. Advancement:** Earned through personal sales, and/or through developing sales volume in member groups as described by CJF management. CJF compensation plan shall determine advancement. While we want you to use and consume CJF products, members are encouraged to resell and use CJF products for samples for 70% or more of their monthly purchases.
- 3. No overrides or commissions earned for sponsoring new members:** Only for sales volume on personal, and/or group member sales, and/or those of their respective groups.
- 4. Shipping & handling (S&H):** Member responsible for S&H on CJF orders and returns. CJF certificate may not be used for S&H.
- 5. CJF new Business Center (BC) setup fee:** A new BC setup fee (\$48) assessed to new members and submitted with application, unless it (new BC charge) is in conflict with an applicable state law, then that state's law shall determine policy.
- 6. Effective date of new member pricing/override schedule/product pricing:** Except for company-wide product price changes, all changes will become effective on the first Member order following CJF company verification of achievement.
- 7. Commissions on new member orders will be paid weekly:** On new member first orders received, and fully processed by the last business day of the week, usually Friday, by 12 Noon CST. The standard accounting period is five business days, and after that all funds are released, unless CJF determines that an additional accounting period is needed. All members grant permission in advance to debit their credit card and/or checking account for charge-backs. Commissions paid by check until CJF debit cards are in place. Matrix commissions paid monthly. Profit sharing bonuses paid quarterly.
- 8. Autoship:** CJF members may voluntarily participate in our autoship program by signing the form that allows CJF to debit their checking account or credit card for the cost (at their level) of a single unit should the member fail to place an order by the middle of any given month. This is a safety feature for member commissions, since participation in autoship is necessary for group overrides, as are timely monthly orders. Member may choose either 5th or 20th of each month for autoship deduction.
- 9. All CJF sales made through our members only.** Independent outside web site sales are NOT allowed.
- 10. Customers Right of Rescission:** Each member must underwrite/offer their customer a three (3) day right of rescission, unless that's in conflict with minimum applicable state law, then that state's law shall determine policy.
- 11. Member returns:** CJF allows our new members a three (3) day right of rescission too. From the time a member receives the shipment, they have three business days only to contact us, and receive a R.A.N. (return authorization number). Since all merchandise is sent to the member from CJF in perfect order, shipping damaged or spoiled merchandise must be claimed against shipper first.
- 12. Member Independence:** Every member is wholly independent, and must conduct their business in a proper and legal fashion. CJF reserves the right to discipline members for improper product claims, poor business practices, and/or for legal, moral, and ethical grounds. To maintain their memberships in good standing, members must reasonably comply with all laws, state, local, and federal.
- 13. Evidence of organizational activity requirement:** CJF reserves right to require members to provide evidence of organizational activity through, but not limited to, a personal member product order being placed with the company each month. Evidence of retail sales activity may be required too, where required by law/legal precedence. In essence, certain minimums apply as prescribed by the company, though verifiable long-term illness and/or age/length of service appropriate retirement is an exception, provided member has a mechanism in place to properly facilitate, and administer the business of that organization.
- 14. No Income/profitability Guarantees:** Any income or profit estimates or figures ever mentioned are intended as examples only, as there is no income guarantee, and no average is either being predicted or implied. There are only examples of those members who do more, and therefore earn more, and those who do less, and therefore earn less. Members are absolutely not allowed to forecast income in the act of recruiting, and/or enrolling new members.
- 15. Misrepresentation by Member:** CJF is absolutely held harmless in all member misrepresentations. Member agrees to absolute and full responsibility for all representations made by them, and/or their representatives, whether they believed it to be accurate or not. Member agrees to vet all promotional materials with company first.
- 16. Right to sell and/or transfer via inheritance:** CJF will allow member the right to confer ownership, including to heir.
- 17. CJF's right to modify terms:** CJF reserves the right to change or modify any or all of its company guidelines, terms, conditions, policies, rules, and modus-operandi at any time, and in whatever manner it sees fit and may do so without prior notice to members, customers or the public. By signing the member application and by placing your first order with CJF, thus becoming a CJF member, you agree to all of these company guidelines, terms, conditions, policies, and rules, and agree to abide by them completely. When a matter between a member and CJF is in dispute, both parties agree that the resolution shall first be decided by these guidelines, terms, conditions, policies, and rules, as decided by CJF management. Failing resolution by that, it will then be decided by an appointed arbitrator. Both parties agree to let that decision stand as a final and binding.
